William A. Adams is a psychologist, Adjunct Professor at Chapman University College, now called Brandman University. He holds a Ph.D. in Cognitive Psychology, with a specialization in computer science from the University of Wisconsin-Milwaukee. He did a postdoctoral fellowship in perception and cognition at Cornell University. Subsequently, he taught undergraduate and graduate courses in psychology, sociology, and statistics at the University of Wisconsin, University of Maryland, and the College of Idaho.

Margunn Bjørnholt holds a cand. mag. in regional planning from the University of Tromsø, an MA in international economics from the College of Europe and a mag. art. (PhD) in economic sociology from the University of Oslo. She is Director of Policy and Social Research AS in Norway and has formerly worked at the Regional Development Fund, the National Institute of Technology, Telemark Research Institute, the Work Research Institute and the University of Oslo. She has been a visiting scholar at Emory University School of Law and GEXcel Center of Gender Excellence in Sweden. Her research interests encompass ethical banking, organisational and spatial flexibility in the public sector, management, gender equality, and workfamily arrangements.

Marcelo da Veiga studied Philosophy, Literature and Pedagogy in Germany. He holds a Professorship for philosophical thinking applied to Education and Business and Administration.
